BE IT FURTHER RESOLVED that the Mayor be authorized and directed to sign and the Clerk attest the said note and affix the corporate seal and the Director of Revenue and Finance be authorized to countersign and negotiate the same in the manner provided by law and apply the proceeds to the proper account of the Borough.
