On resolution the Commissioners authorized the renewal of the Tax title notes of the Borough,# 25,for \$3534.99,and #26 for \$3262.22,at 5 per cent.and upon resolution approved the acceptance of a third ~~tax~~ title note from the Borough,covering the appropriation of the Sinking fund for 1924, \$3262.22 @ 5 per cent.

On resolution the Commission authorized the employment of H.J. La Wall to close the books of the Commissioners for 1924.

On Motion the Commission adjourned to meet at the Guarantee Trust Company,on Saturday morning,January 24th to cut coupons and attend to the necessary business.
